Amateurs Status, Guidelines:

1. **You are considered an amateur if you have less than 5 individual NICA medals.**
 - Also, amateurs can forfeit their status at any time.
 - Medals earned in team events do not count as medals towards pro status
2. **Amateurs can compete in Pro events and not lose their amateur status**
 - They are eligible for prizes, medals, placing
 - Amateurs can compete in all events based on availability
 Including Olympic qualifiers.
3. **Amateurs can compete with pros in team events**
